By accepting this Agreement, You agree to the following terms and conditions for Your present and future Contributions submitted by You to a Terracotta Project.

1. "Contribution" means any source code, object code, patch, tool, sample, graphic, specification, manual, documentation, e-mail, comment, posting, communication, or any other material, including but not limited to any original work of authorship, including any modifications or additions to an existing work, posted or submitted by You to Terracotta for inclusion in, or documentation of, any Terracotta Project.
2. "Intellectual Property Rights" means all worldwide rights associated with any Contribution, including copyrights and moral rights, trademark and trade name rights and similar rights, trade secret rights and other proprietary rights in software and other types of technology, and registrations, applications, renewals, extensions, combinations, divisions, or reissues of the foregoing.
3. Subject to the terms and conditions of this Agreement, You hereby assign to Terracotta all Intellectual Property Rights in any Contribution to Terracotta, and You agree that Terracotta may therefore reproduce, distribute, prepare derivative works of, publicly display, publicly perform, sublicense, and/or assign the Contribution, as well as take any other action(s) that may be permitted under applicable law or in equity.
4. You hereby grant to Terracotta and to all recipients of any product distributed by Terracotta a perpetual, worldwide, non-exclusive, no-charge, royalty-free, irrevocable license under any patents owned or licensable by You at any time without payment to third parties, to make, have made, use, sell, offer to sell, import, and otherwise transfer the Contribution in whole or in part, alone or in combination with or included in any product, work or materials arising out of the project to which the Contribution was submitted, and to sublicense the foregoing rights to third parties through multiple tiers of sublicensees or other licensing mechanisms at Terracotta's option. Terracotta may assign this Agreement and any rights set forth herein to Software AG USA, Inc. or any other Terracotta affiliate(s).
5. The assignment and licenses granted pursuant to this Agreement are effective on the date You first submitted a Contribution to Terracotta, even if such submission preceded the date below. This Agreement shall be governed by the laws of the State of California and applicable United States federal law, without application of choice of law rules. You represent that Your Contribution is an original work and that You are legally entitled to grant the rights and privileges conveyed by this Agreement. You warrant that Your Contribution, to the best of Your knowledge, does not violate any other party's copyrights, trademarks, patents, or other intellectual property rights. If this Agreement is being submitted on behalf of a company it must be signed by a duly-authorized representative.
